**Re: Combined Scrutinizer's Report on results of Remote E-Voting and voting through Polling/Ballot Paper Conducted on the resolutions placed at the Extra-Ordinary General Meeting of the Company on 30th March, 2019 at 11:00 AM**

1. I, Ms. Priti Lakhota, Practicing Company Secretary, ( CP No: 12790) have been appointed by the Board of Directors of **Merino Industries Limited** (" the company") as the Scrutinizer for the purpose of remote e-voting and voting through Polling/Ballot Paper received from the equity shareholders carried out as per the provisions of Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management & Administration) Rules, 2014, as amended, to ascertain the requisite majority in respect of the below mentioned resolutions at the Extra-Ordinary General Meeting(EGM) of the Company held on 30th March, 2019.
2. The Management of the company is responsible to ensure compliance with the requirements of the Companies Act, 2013 and Rules thereto relating to voting through electronic means on the resolutions contained in the Notice dated 04<sup>th</sup> March, 2019 of the EGM of the Members of the Company.
